

Potential Health Effects

4. First Aid Measures

Inhalation:

5. Fire Fighting Measures

Fire:

As with most organic solids, fire is possible at elevated temperatures or by contact with an ignition source. Slight fire hazard when exposed to heat or flame.

Ventilation System:
